LEGISLATIVE REPORT

As retired educators, we are concerned that our health benefits are not protected nor adequately funded. Health benefits for educators, retired and active, are not paid by the state as they are for state employees. Boards of education provide them and they have no contractual agreement to do so. The loss of these benefits are especially disastrous for older retirees whose benefits are based on smaller salaries. The actions of legislators in moving part of pension costs to local jurisdictions put additional pressures on local funding. The general assembly is aware of this potential adverse impact on health benefits for retirees. Leadership by the legislature to promote long term solutions to the challenge of maintaining health benefits for retirees is essential. Every one of us needs to call our representatives regularly with our concerns.
